# WASTEWATER TREATMENT — STAND-ALONE WASTEWATER TREATMENT SYSTEMS FOR ISOLATED DWELLINGS

# 1 PURPOSE

The purpose of this standard is to establish the performance of stand-alone wastewater treatment systems used to treat wastewater from isolated dwellings and to specify test methods for verifying compliance of this performance in relation to requirements established by regulatory authorities.

## 2 SCOPE

This standard applies to stand-alone wastewater systems used to treat wastewater from an isolated dwelling.
